➤ What are glueboards?

Glueboards are what they sound like: boards covered in glue. They are used as a form of pest control for animals like rats or mice.

➤ Why eliminate them?

Inhumane

Animals caught by glueboards are often left to die excruciating, slow deaths by starvation, suffocation, and dehydration. Many of them will struggle for days to tear their fur or chew through their limbs in a desperate attempt to free themselves.

Indiscriminate

Glueboards catch countless non-target animals every year, including cats, rabbits, geckos, and birds. These creatures suffer the same terrible fate as any mouse or rat caught in a glueboard.

Unhygienic

With animals left dead or dying in these traps for days or even weeks, glueboards can become a cesspool of disease and bacteria. This poses a threat to anyone handling the boards or anything touching them.

Ineffective

Studies have shown that glueboards are less effective than live traps or snap traps. And they don't deal with the source of the problem. New technologies can make pest exclusion quicker, more effective, and more humane.
